Serving a Greater Good using the
UCCP COVENANT
Rooted in Matthew 18:15-17

Matthew 18: 15 *“If you feel there is an error (or a possibility), go and point it out when the two of you are alone. If you are attended to and understood, you have regained that one.*

16 *But if you are not attended to and understood, take one or two others along with you, so that every word may be confirmed by the evidence of two or three witnesses.*

17 *If you are still refused attention and understanding, tell it to the church” (in our case, the Council)..*

1. Take your Possibility or Problem to the staff or lay leader lowest and closest to the issue (staff, branch, committee or team) If you don't know who to go to... seek help from Council members or your Pastor.
2. If you feel their response is not in harmony with our vision-mission (in the Way of Jesus) or our by-laws/constitution, engage another congregant for support to approach them again.
3. If your Possibility or Problem is still unresolved, you and your support can take it to a Council member who, if they cannot help you resolve it, can bring it to Council (Church) for resolution.
4. Even if the Council denies the outcomes you prefer, any congregant member may place a motion into our twice-annual meetings or call a Special Meeting by gaining the support of 20% of the membership.
5. This process does not guarantee that anyone's personal preference or outcomes will be affirmed. It only assures a biblically-rooted process in harmony with our faith, vision-mission and core values.

MEMBER COVENANT in the form of a LITANY

Leader: We are called together, bound in covenant and gifted with the Spirit. As we sustain the work of the church, we reaffirm our covenant with each other:

All: We will treat each other with kindness and caring and maintain an attitude of Christian love in all we do. We will make every effort to communicate in ways that are truthful, fair and which build up the body of Christ.

Leader: We will work to build an atmosphere of safety and trust through respectful conversation, open meetings and congregational forums.

All: We will mutually support one another in our joys, needs and concerns through spiritual support, physical help and prayer. We will honor confidentiality and refrain from gossip, so that each member can share joys and concerns in their own time.

Leader: We trust and support our leaders. We willingly, openly and respectfully share our concerns with them.

All: When misunderstandings occur, whether between members or with our pastor, we will speak directly to the person involved and seek to resolve the conflict in a timely and loving way. In our conflict we will express concerns, ask questions, explore differences, look for options and seek reconciliation in the spirit of Jesus Christ.

Leader: When we believe that our life together as a community of faith is in crisis, we will seek outside help and work together to find resolution.

All: It is our covenant with each member of this congregation that we will walk with one another through conflict and difference, speaking the truth in love, seeking reconciliation and the grace of God.

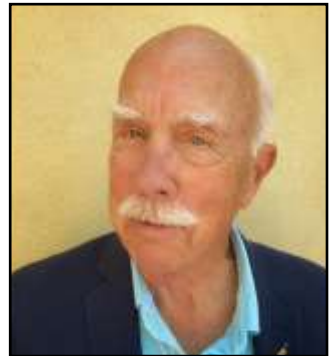
