Learn more about Studios at Montero with COTS

<u>Studios at Montero</u> is the result of a successful partnership to convert a dilapidated and dangerous 50-year-old motel into 60 units of newly remodeled permanent supportive housing for chronically homeless people in Sonoma County. COTS has partnered with Burbank Housing and the City of Petaluma on this incredible project. Studios at Montero ("SAM") officially welcomed the first tenants earlier this month. All 60 units at SAM are fully remodeled studio units which come fully furnished. We at UCCP are partnering with COTS to provide one of the new tenants with a <u>welcome-home basket</u> full of household goods to help ensure a successful and warm transition into their new homes.

The Studios at Montero offers long-term, wraparound supportive services at this project, ensuring tenants feel safe and supported during their transition into permanent housing. Tenants are offered comprehensive case management, peer support services, access to onsite and offsite group recreation, healthcare coordination, and many other supportive services to help create a sense of safety, self-sufficiency, and instill confidence.

Projects like Studios at Montero bring hope to those experiencing homelessness right here in Sonoma County. Feed All Who Hunger: Repeal Drug Felony Ban on SNAP

Denying access to a vital program like SNAP because of past or current involvement with the drug trade does not promote public safety or deter crime. Rather, it adds another cruel and needless barrier to successful re-entry and rebuilding of lives. Due to discrimination in the workforce of people with criminal records, those with felony convictions are at greater risk of poverty and hunger which in turn adds more difficulty in securing employment, housing, and other essential needs, especially those critical to addiction recovery. Banning people for prior convictions increases the likelihood of recidivism. It also exacerbates hunger for their family by denying resources to feed their children or elders in their care. Maintaining this ban says that our society believes some people deserve to go hungry. Congress has the opportunity to right this wrong by passing the Re-Entry Support Through Opportunities for Resources and Essentials (RESTORE) Act. This bill would reform the 1996 law and repeal the SNAP ban for

felony drug convictions. It could also be incorporated in this year's Farm Bill, which authorizes SNAP. As people of faith seeking to love mercy and do justice, we must lift our collective voices and tell our leaders that hunger should not be a reality for anyone. <u>Click here</u> to Take Action

Petaluma Climate Justice

The Petaluma Equitable Climate Action Coalition (PECAC) partnered with the City of Petaluma to conduct a 6-month equitable civic engagement program designed to help the City better understand how vulnerable communities are impacted by climate change – and how we can mitigate these impacts by making public transportation, bike lanes, and sidewalks more accessible. 
Tell Congress to Pass the Recovering America's Wildlife Act

Our nation's wildlife faces multiple threats in the form of habitat fragmentation and degradation, disease, invasive species, pollution, and extreme weather disasters. According to the National Wildlife Federation, one-third of America's wildlife species are at the risk of extinction. All categories of animals are seeing population declines, with 150 U.S. species already declared extinct, over 1,600 listed as endangered, and nearly 500 species have gone unseen for decades that are possibly extinct. This is not only an unfortunate loss of biodiversity but also harms humans ecologically and economically. What harms our furry, feathered, and scaley neighbors also inevitably harms us. In 2021, the UCC General Synod called on the church to "promote the Rights of Nature," Let us take up our sacred responsibility to protect all life beginning with this land. Raise Your Voice to End Gun Violence

It feels like each week we are grieving yet another tragic loss of life due to gun violence. And it's no wonder; our country is flooded with guns. It's easier to buy a gun than many other regulated goods, including Sudafed (which requires an I.D. and there's a limit on the amount you can buy). Nearly half of the civilian-owned guns in the world are owned by U.S. citizens. Our elected leaders have the power to do more to end gun violence. This includes robust background check legislation, closing loopholes on gun sales (making sure it's difficult for people who want to commit violence to access weapons), safe storage laws, community violence prevention, and importantly an assault and high capacity weapons ban. Support Transgender Healthcare

The well-being of transgender and non-binary youth is being debated in legislative sessions across the United States. As of March 3 there have been 385 anti-LGBTQ bills introduced, with 108 of these bills aiming to end gender affirming healthcare for trans and non-binary youth. This places more than 54,000 trans youth actively taking life-saving gender affirming medical care at risk. This is the highest number of anti-LGBTQ bills ever introduced in a single legislative
